WHEREAS the said Agreement ensures the **Province of New Brunswick, District Education Council and First Nation's** community, through the District First Nation Education Committee, work collaboratively to develop and implement a District First Nation Education Plan that responds to the unique needs of **First Nation** learners and reflects the Provincial Aboriginal Education Committee's strategic plan, *New Paths in First Nation Education*, and


WHEREAS the Pabineau First Nation is committed to work in good faith to provide general and special educational programs and services to the students of the **First Nation** through this Agreement, and

WHEREAS the development of the District First Nation Education Plan will commence with the signing of this *Enhanced First Nation Education Programs and Services Agreement*, and


